## Tuesday, February 28, 2023 – Consolidated Primary Election General Information

### Candidate Filing Dates & Deadlines

**Monday, November 21 – Monday, November 28:** Petition filing period for established political party candidates & nonpartisan candidates (municipalities)

**Monday, December 5:** Last day for filing objections to nomination papers of candidates who filed during the November 21 – November 28 filing period

**Wednesday, December 7:** Last day to conduct ballot placement lottery

**Thursday, December 22:** Last day to file a Withdrawal of Candidacy with the local election official or authority

**Thursday, December 29:** Last day to file a notarized Declaration of Intent to be a Write-in Candidate

### Referenda Question Deadlines

**Monday, November 28:** Last day for filing petitions for referenda for the submission of questions of public policy with the local election official

**Monday, December 12:** Last day for local governing boards to adopt a resolution or ordinance to allow a binding public question to appear on the ballot

### Certification of Ballot Deadline

**Thursday, December 22:** Last day for the local election official to certify candidates, offices and any referenda questions to the election authority

### Voter Registration, Early Voting & Mail Voting

**Friday, January 13:** Military & overseas ballots available

**Thursday, January 19:** First day to mail ballots (if available)

**Tuesday, January 31:** Voter registration closes for deputy registrars and local election officials

**Wednesday, February 1 – Monday, February 27** Grace period registration & voting period

**Sunday, February 12:** Online voter registration closes

**Monday, February 13 – Monday, February 27:** Early Voting period

**Thursday, February 23:** Last day to apply for a ballot by mail

### Ballot Counting & Canvassing Results Dates

**Tuesday, March 14:** Deadline for validating and counting provisional ballots and late-arriving mail ballots

**Tuesday, March 21:** Last day for County Clerk to canvass election results and proclaim results
